NOTICE INVITING TENDER/REQUEST FOR PROPOSAL

The **High Commission of India in Kampala (Uganda)** invites bids from reputed companies to undertake works which are listed in the '**Scope of Work**' below, with the aim of being selected to competitively price the works in order to carry out the said work at **India House, Plot No. 5, Hill Lane, Kololo, Kampala**.

(A) Scope of Work:

1. Removing the existing paint on exterior of the house (including walls, doors, grills and other surfaces) by scrapping, sand papering and preparing the surface smooth including necessary repairs to scratches etc. complete.
2. Painting the surfaces with 'A' grade material to give an even shade (two or more coat).
3. The job will have a warranty of two year.

(B) Eligibility Criteria:

1. Bidders should have technical, professional and practical experience of at least 10 years in executing similar jobs. They will need to provide details of similar works undertaken in the last three years, including such works carried out in any of the Diplomatic Missions in Kampala.
2. Bidders may also submit, in brief, the history of their company with annual turnover.
3. Bidders should have the license of KCCA to execute the above job, if awarded.
4. Bidders should confirm that they are able to inspect the said property existing at **Plot No. 5, Hill Lane, Kololo, Kampala**.
5. To assist evaluation and comparison of the bids, the High Commission at its discretion, may ask the bidders for clarification on their bids. The clarifications and responses from the bidders shall be in writing.
6. If a bidder is asked to competitively quote for works, the High Commission is not bound to accept the lowest quote or any tender, and reserves the right to accept the whole or any part of the tender and altering the quantities offered and the tenderer shall supply the same at the rate quoted.

7. Bidders should not have been barred/black-listed by the Governmental department/ Organization in India/Uganda or elsewhere (The bidder is requested to submit a self-declaration to this effect).
8. Bidders may submit their bids on 'fixed price lump sum' basis.

(C) Inspection of the site

Interested bidders can visit the said property between 10 am to 4 pm between 19.03.2018 to 26.03.2018.

(D) Submission of Bid:

1. The sealed bids should be submitted and super-scribed with "Painting work at India House".
2. Sealed offers addressed to the under mentioned shall be submitted on or before 5 pm on 28.03.2018:

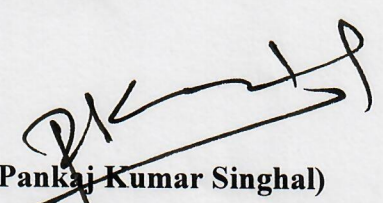
